Item empanelment is required for receiving invitation for participating in Single / Limited tenders. To obtain tender enquires from a Center/Unit, Vendors have to get empanelled against pre-defined Category of Items of the respective Centre/Unit on ISRO e-Procurement portal.

Digital Signature Certificate is essential to Login to ISRO e-Procurement portal and submit bids. Vendors may get registered with a valid DC. Those who have already registered on the portal may login to the portal periodically for viewing Tenders carrying on bidding process.

Vendor registration can be done only by authorized persons of the company. He should posses the following:-

- 1. Digital Certificate issued by a Certifying Authority (CA) in India
- 2. Company e-mail ID for communication

Registration process consists of vendor registration and item empanelment. Registration enables the vendor to participate in Public Tenders released by any of the above mentioned Centre/Unit. Item empanelment is needed for participating in Limited Tender (LT)/Single Tender (ST). To obtain enquires for LT/ST, foreign vendors has to get empanelled against the defined category of items of the respective Centre/Unit.

Instruction related to DC for foreign vendors

1. Foreign vendors can register in our e-procurement portal with valid DC issued by Indian CA only. If the vendor already possesses a valid Indian DC, vendor registration can be done using the existing DC. Otherwise the vendor has to procure a new DC.

- 2. Foreign vendors shall obtain a Class III DC (Digital Certificate) from a licensed CA (Certifying Authority). At present following organizations are authorized CAs
 - (n)Code Solutions CA(GNFC)
 - Safescript(SIFY)
 - TCS
 - MTNL
 - Customs and Central Excise
 - E-Mudhar
 - IDRBT
- 3. Foreign Vendors are requested to visit web sites of the above mentioned organizations for details regarding list of authorized documents to be submitted and also other statutory requirements for obtaining a DC. It is a safe and proper method to get a DC on e-token, a password protected USB device.
- 4. If required, ISRO can provide an authorization letter to foreign vendors for obtaining a new DC from Indian CAs.

Pre-Requisites to work with ISRO E-Procurement System:

1. Operating System: Windows XP (Service pack 3) and above

2. Internet Explorer version 7.0 and above with cipher strength 256 bit (This can be checked by clicking on Help -> About Internet Explorer)

3. Four components to be installed on the PC. Application will guide you at appropriate page to install the utilities.

However, these components are also available on the home page through the 'E-procure installer' link. The components are:

a. Number to Word Conversion Utility

b. Password Utility

c. E-Token Utility

d. Encryption Utility

4. Administrative rights are required to install the utilities on your Local computer.

5. Add the portal in Trusted site by clicking Tools ->Internet Options -> Security -> Trusted sites -> Sites. Application will prompt you with appropriate page https://*.eprocure.isro.gov.in

6. Settings for ActiveX controls. Set the Security level to 'Low'.

7. Settings for Vista Operating System (This can be done by clicking Start -> Control Panel -> User Accounts -> Turn User Account control on or off -> Uncheck the option 'Use User Account Control (UAC) to help protect your computer' -> click on 'OK' and restart your PC.

8. Class 3 Digital Certificate and an E-mail ID (Public E-mail ID likes Gmail, Yahoo, etc. are not allowed) are mandatory for using ISRO e-procurement Application.

After completing the Pre-requisites you may refer the Illustrative Demos for understanding Registration process in detail which is available on the Home Page.

During registration, an Authentication Mail will be sent to the specified E-mail ID, which needs to be responded as indicated in the mail.

Vendor Registration process

Vendors have to register themselves on the ISRO e-Procurement portal to participate in any tender. The following section outlines the procedure for 'Vendor Registration'.

1. Load the homepage of the portal by accessing the following Uniform Resource Locater (URL) / Website Address: 'https://eprocure.isro.gov.in'

2. Click on the link 'Click Here to REGISTER' on the home page to initiate the registration process.

3. Steps for vendor registration process are as follow:-

Step 1: Sign and Verify Digital CertificateStep 2: Accept Terms and ConditionsStep 3: Create user credentialsStep 4: Login using created user credentialsStep 5: Fill registration formStep 6: Validate email

4. On the same page, please read Terms & Conditions. If Terms & Conditions are not acceptable please exit the registration process.

5. Please click on 'Digital Signature' to sign & verify your certificate.

6. In case, e-procure utilities are not installed in your system, Application will guide for the installation of utilities. Click on 'Digital Signature' once again.

7. Click on 'Accept' to accept terms and conditions set by ISRO.

8. You will get a form to fill up basic user information. Following information are to be provided at this stage.

*Note: Please preserve the password for future. The password will be required at the time of replacing the Expired 'Digital Signature' certificate with a new one.

9. Click on 'Submit' after filling the above details.

Note:

a) If User ID is not available, you can either select the User ID from the suggested list of User IDs or provide new user ID.

b) If your company is already registered with ISRO, system will display the list of companies. You can Select your company name. However, your registration is subject to the approval by the primery user of the company selected.

10. Click on 'Proceed' button.

11. Click on 'Select Certificate' to enable the login with appropriate Digital Certificate.

12. Click on 'Login' and login with your User ID and Digital certificate.

13. Click on 'Fill Registration Info' to fill up registration form.

14. Fill up the following information by entering valid information and selecting most appropriate Option, where applicable.

17. Click on 'Done' to submit your information

18. An email will be sent to the email ID provided by you during registration.

19. Please login to your email and click on 'Validate Login' to complete your registration process.

20. Registration of the vendor will be approved automatically by the system and the vendor will receive a mail indicating the successful registration of the vendor.

Item Empanelment Process

1. You have to click on 'CENTRES/UNITS' to select a centre for Empanelment.

2. Select the Centre for which, you wish to get empanelled.

3. Click on 'Item Empanelment'.

4. Select a main item for empanelment.

5. Select a sub item of the main item for empanelment.

6. Enter the name of contact person and Email ID, if it is different from the primary contact. (Optional)

7. Click on 'Save' and 'Done' to complete the Empanelment process.

8. Repeat this empanelment process for all the centre where you want to get empanelled.

ISRO authority of the respective centre will assess the Empanelment request of each vendor. You will be able to participate in the tendering activities for Limited Tenders only after the approval of empanelment.

For participating Public Tender Item empanelment not required.
