I am Nagendra Kumar Sannidhiraju, Deputy Manager (Security Systems), SDSC SHAR.

Q2) PI state briefly about the Access Control System (ACS) maintained at SDSC SHAR and your role thereon as Deputy Manager (SS).


Biometric based Access Control System is operational in SDSC SHAR. Employees enter / exit office by way of swipe-in/swipe-out through the turn-stile gates installed with ACS readers. All entry & exit details of employees are captured through the system and stored in the data-base for ready reference at any point of time. As Deputy Manager (SS), I am responsible to keep the ACS systems operational. I also generate various ACS reports towards day-to-day monitoring and on need-basis.


Q3) PI see Exhibit S-14 document and state whether you can identify it.


Yes, this document is the Access Report of Shri Rameshwar Kumar, SH 14653, for the period from 09.04.2019 to 26.06.2023. This document has been generated from the ACS data-base and I confirm that it is authentic and genuine.

Q4) PI see Exhibit S-14 and state whether the CO has attended duty.

As per the ACS report, the CO has entered office-premises only on 2 days – i.e on 27.01.2021 & 29.01.2021 - during the period from 09.04.2019 to 26.06.2023. On 27.01.2021, his presence in office was from 10:59:19 hrs to 11:20:07 hrs (about 21 minutes). On 29.01.2021, his presence in office was from 15:47:36 hrs to 17:05:49 hrs (about 1hr & 18 minutes).



Q7) Please state the name of the ACS reader(s) that would have reflected in the Exhibit S-14 ACS Report, had the CO performed duty at 'Quality Division – SPP of Solid Motor Production & Testing Group (SMPT-SR)'.

There are two ways to go there. Had the CO entered via Gate-2, the ACS would have recorded Gate2_Number of any one turn-stile. There are 14 turnstiles at Gate 2. Had the CO entered via SPP West gate, the ACS would have recorded SPP Gate_ Number of the turnstile. There are 3 turnstiles at SPP west gate
